Dear President Biden, Secretary Mayorkas, and Secretary Blinken:

We write to express our profound disappointment by the Department of Homeland Security's decision to use Title 42 to expel Venezuelans seeking refuge at the U.S.-Mexico border.<sup>1</sup> This decision places thousands of displaced asylum seekers at risk, does not align with our nation's values, and violates our legal obligations under domestic and international law. We urge you to reassess this decision and ensure that all individuals have access to our nation's asylum system.

On April 1, 2022, the Director of the Centers for Disease Control and Prevention (CDC) announced the termination of the Title 42 public health order.<sup>2</sup> Reports indicate that Dr. Marty Cetron, Director of the CDC's Division of Global Migration and Quarantine, refused to sign an order to invoke Title 42 after his team did not find sufficient public health evidence to justify the action.<sup>3</sup> Dr. Cetron worried that Title 42 would lead to an "inappropriate epidemic of stigma and misrepresentation" against migrants.<sup>4</sup> This week, the House Select Subcommittee on the Coronavirus Crisis issued a report referencing Dr. Cetron's concerns that Title 42 is morally wrong and is used "to keep Hispanics out of the country."<sup>5</sup> The use of Title 42 continues to be morally wrong, discriminatory, and unlawful today.

The United Nations High Commissioner for Refugees categorized the situation in Venezuela as the "second largest external displacement crisis in the world."<sup>6</sup> Families are fleeing violence, insecurity, persecution, malnutrition, as well as the lack of medicine and essential services in Venezuela. Asylum seekers, including families with children, are crossing rivers, scaling mountains, and traversing the Darien Gap, with the hope of reaching safety in the United States.<sup>7</sup> It is cruel and unlawful to turn our backs on these families as they attempt to make their claims for asylum.

It is particularly troubling for the Department of Homeland Security to force Venezuelan asylum seekers to return to Mexico using Title 42 given how the Administration has already determined that forcing migrants to return to Mexico poses a danger to their lives. When terminating the Migrant Protection Protocols (MPP), also known as the Remain in Mexico Program, the Department of Homeland Security found that migrants sent to Mexico were "subject to extreme violence and insecurity at the hands of transnational criminal organization that profited by exploiting migrants' vulnerabilities."<sup>8</sup> Organizations such as Human Rights First, have corroborated this by documenting how thousands of asylum seekers and migrants have been kidnapped, raped, or attacked after being expelled to Mexico due to Title 42.<sup>9</sup>

These facts make clear that Title 42 violates our nation's domestic and international legal obligations by placing asylum seekers at risk of extreme violence. The non-refoulement principle in Article 33 of the Refugee Convention and Article 3 of the Convention Against Torture prohibits states from expelling individuals to countries where they face danger. Congress formally recognized these obligations by enacting the Refugee Act of 1980.

It is critical that the Administration reassess the decision to implement Title 42 against Venezuelan asylum seekers at the U.S.-Mexico border. We have a moral and legal responsibility to ensure that our immigration policies respect human rights and recognize the dignity of all human beings seeking refuge. Thank you for your attention to this matter.
