- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "GSA Technology Ac-
- 5 countability Act".

1	SEC. 2. TRANSPARENCY OF GSA FUNDED INFORMATION
2	TECHNOLOGY SERVICES.
3	(a) Transparency on Use of the Federal Cit-
4	IZEN SERVICES FUND.—Section 323 of title 40, United
5	States Code, is amended by adding at the end the fol-
6	lowing:
7	"(g) Requirement for Annual Report to Con-
8	GRESS.—The Administrator shall submit a report to the
9	Committee on Oversight and Accountability of the House
10	of Representatives and the Committee on Homeland Secu-
11	rity and Governmental Affairs of the Senate not later than
12	September 30 of each year, which shall include, at a min-
13	imum, the following:
14	"(1) A list of each project funded by expendi-
15	tures during the previous year, or that have been
16	funded by expenditures in the previous five-year pe-
17	riod, including the following:
18	"(A) An explanation of the project.
19	"(B) An explanation of the project's
20	progress, including a description of any major
21	changes to project scope, project cost, or project
22	funding; a description of any project delays;
23	and an explanation for any abandoned or failed
24	projects.

6	"(i) Definitions.—In this section:
7	"(1) Administrator.—The term 'Adminis-

9	"(2) Expenditure.—The terms 'expenditure'
10	means any obligation of funds from the Acquisition
11	Services Fund for personal services related to the
12	provision of information technology authorized by
13	subsection $(c)(1)(A)(iii)$.
14	"(3) Project.—The term 'project' means serv-
15	ices provided by the General Services Administration
16	that are funded in whole or in part by an expendi-
17	ture.".
18	(c) Effective Date.—The amendment made by
19	this Act shall take effect on the commencement of the first
20	fiscal year after the date of the enactment of this Act.
