Dear Virginians,

Since I first sought this office, I have made it crystal clear what my values are, the principles I stand for, and the key issues I will primarily focus on. I take these strong and unequivocal stands because I want the people of the 5th District to know who is representing them: a constitutional conservative who fights courageously and relentlessly for the Judeo-Christian principles of our Founders.

This is the foundational path I believe we must follow to get America back on the right track. We simply cannot sit back and stay quiet as those on the Left fight for the things that will destroy the greatness of America.

As I have said for the past two years, the top issues facing our nation are the priorities of our broken education system, the invasion at our Southern Border, and the reckless spending that is causing historic inflation and bankrupting future generations. It is also abundantly clear that ending unconstitutional and unnecessary federal COVID mandates, and restoring faith in the integrity of our elections is critically important.

When you review my legislative record, you will see that the work I have done and the votes I have taken are *entirely consistent* with the promises I made. And, I am always willing and able to explain and defend the votes that I take.

In fact, I am a regular guest on four talk-radio shows that are far-reaching in the district, with no questions off limits regarding my record. I have also conducted seven telephone town hall meetings, enabling thousands of Virginians to participate and hear me answer unscripted questions directly from constituents on virtually every subject you can imagine.

Typical politicians avoid the tough questions, but I am always willing to tell you where I stand and why.

I am fighting for our values by introducing bills, voting on legislation, and working through my assigned Education & Labor and Budget Committees. My office is among the leaders in the "Freshman Class" in the House when it comes to introducing bills. These bills are indicative of what a common sense conservative agenda should contain, even if Speaker Pelosi will never put them on the House floor for a vote.

At the same time, I have made it a **priority for my staff to** responsively serve the needs of constituents in the 5th District.

When I took office in January of 2021, unnecessary COVID policies had virtually shut down access to the federal government, with most agency offices closed and thousands of federal employees not working at all. I was determined from the beginning that our office would provide the best possible constituent service, and would end the practice of my predecessor and other current members of congress whose staff was in a remote office accepting meetings by appointment only. We opened multiple channels to reach Virginians and make our office available when they need help cutting through bureaucratic red tape. As a result of these efforts, we have visited with nearly 3,000 Virginians who came to us for assistance.

As you will see from the pages that follow, my record of constituent service and legislative activity are consistent with the promises I made. <u>This report serves as another measure of accountability to you – the people I serve.</u>

I look forward to continuing this record of service to everyone in the 5th District in 2022 and beyond.

## **SERVING VIRGINIANS**

Our team continues to work hard for Virginians across the 5th District. Since I took office in January 2021:

- We have responded to over 43,250 messages from constituents in writing.
- We have helped resolve more than <u>2,335</u> cases our constituents had with <u>federal agencies</u>.
- We are *currently* working to cut through bureaucratic red tape for nearly 600 more Virginians.
- As a result, our office facilitated the successful return of more than <u>\$10</u> million in benefits owed to Virginians by their federal government.

One of the ways we work to serve you more effectively is by conducting **Mobile Office Hours** in your community. Instead of asking you to drive a long distance to a stationary district office, each month members of my team travel around the 5th District to bring you the convenience of meeting with a congressional staff member face-to-face.

Thus far, my team has conducted more than 250 of these meetings.

What types of issues can we help with? We work with hundreds of federal agencies including:

- Internal Revenue Service 489Cases
- United States Postal Service 246 Cases
- Veterans Affairs 235 Cases
- State Department (Passports) 203 Cases
- Social Security Administration 183 Cases
- Immigration 176 Cases
- Small Business Administration 48 Cases

One of the untold stories of the unnecessary COVID lockdowns is the closed federal agency offices and unanswered phone calls and emails by those who are supposed to be helping the taxpayers they serve. In February, I hosted a listening session in my district office about the service issues our constituents face when working with the Social Security Administration and the Internal Revenue Service.



I was so thankful to everyone who came and shared their personal stories about attempting to navigate the federal bureaucracy. While my team fights hard every day to make progress with federal agencies and to cut through red tape on behalf of Virginians, there are bigger issues that must be resolved to correct the treatment many of our constituents are receiving.

Much of the "lag" time that we have come to know as "normal" response times from the Social Security Administration, Internal Revenue Service, and other federal agencies, is the unfortunate consequence of federal employees teleworking, or getting paid not to work at all, for the last two years. While I am encouraged that more offices are committed to resuming a more regular schedule, we will keep pushing for the reopening of all federal buildings and the return to in-person work for everyone, to make sure taxpayers get the service they deserve.

Over the past year, mail delivery has often been unreliable in the 5th District. Constituents have contacted our office about the delays, including bills and medications arriving late, or not at all. The most serious delays have been in Albemarle County and Charlottesville, and I traveled to receive an in-person brief at the Charlottesville USPS facility in April.



Last fall, I wrote a letter to Postmaster General DeJoy asking for relief. My team and I have been in regular contact with USPS, and it is clear that the USPS is struggling to recruit and retain workers to fill all of their routes. The main cause is the Biden Administration policies that have paid many workers to stay home, grown the welfare state, and ultimately shrunk the labor force.

We have been working with USPS to assist with local recruitment efforts, including helping promote their hiring efforts and the job openings in Charlottesville and across Albemarle County. I will continue to work with them to help restore normal mail service across the 5th District.

Serving veterans and their families is one of my highest priorities. Whether it's securing health care benefits from the VA or medals for their heroic service, my team and I are honored to work on their behalf.



Mr. Martin Harris (pictured above) served our nation during World War II, and we were able to secure long-overdue medals that honored his service to our country. We are now partnering with the Vietnam War Commemoration to find eligible Vietnam-era veterans and their families in order to honor them. Recently, we were also made aware that some Virginia veterans were suffering because the VA was not properly implementing a law known as the VA MISSION Act. Under the MISSION Act, the VA Community Care Program is supposed to provide qualifying veterans with the flexibility of receiving care in their community from local providers rather than only at a VA health care facility, if wait times are too long. For example, the Charlottesville VA Clinic has an average wait time of 61 days for new patient primary care.

This program was supposed to represent an exciting step toward ensuring that our nation's heroes have timely and convenient access to quality health care services.

This option is especially important for our constituents who live in rural areas and oftentimes must drive a long distance to get to the nearest VA health facility.

So, I sent a letter to the VA's Inspector General, joined by my Republican colleagues in Virginia and West Virginia, demanding answers regarding how the VA is complying with the requirements of the MISSION Act. The letter is only the first step to ensure our veterans receive the care they need, when they need it. We will continue to follow up with the VA until our veterans get the care they were promised.

## My Legislative Record

I have focused on introducing bills that are consistent with what I promised voters when asking for their support. I have directed my team to take my vision for a better, stronger America, and begin to put it in the form of legislation. And, when someone else in Congress has a good idea that reflects my constitutionally conservative principles, we are joining them in their efforts and co-sponsoring those bills.

To date, I have introduced 31 pieces of legislation and have co-sponsored 318 bills and resolutions introduced by others. I have also weighed into key issues by leading and signing onto letters demanding answers from the executive branch.

## 31 Bills and Resolutions Introduced

## **Restoring Sanity in Education**

I am committed to putting the education of our children first, supporting parents instead of teacher unions, and fighting woke indoctrination.

## 1. H.R. 1498, Students Before Unions Act

This bill would make COVID education funding contingent upon local jurisdictions recording and providing written disclosure of any communication they have with their teacher's union regarding reopening to in-person learning.

#### 2. H.R. 3704, The CHOICE Act

This bill would provide struggling families the choice of having federal education funds follow their students to the school of their choice or deposited into a 529 savings account.

## 3. H.R. 5047, Empowering Local Curriculum Act

This bill would ensure that state and local governments are not required to teach CRT as a condition of receiving federal funds.

## 4. H.R.5731, Championing our Parents Act of 2021

This bill would prohibit any federal funds from being used to implement Attorney General Garland's October 4<sup>th</sup> Memorandum supporting the investigation of parents attending school board meetings.

## 5. H.R.5398, Defending Students' Civil Rights Act of 2021

This bill would clarify that it is a violation of the Civil Rights Act of 1964 to teach Critical Race Theory in schools receiving federal funding.

## 6. H.R. 7058, Federal Student Loan Integrity Act

This bill would prohibit the Biden Administration from extending the moratorium on student loans, recognizing most people receiving the benefits are higher earners with good jobs.

## Reforming the Way Government Works and Spends Our Money

Politicians in Washington have failed our children by leaving more than \$30 trillion in debt to future generations, and have severely jeopardized our nation's fiscal viability. I am committed to balancing the federal budget, promoting economic growth through reduced regulations, and reducing the size and scope of the government and its control over our lives.

### 7. H.R. 2577, Article I Regulatory Budget Act

The bill would amend the Congressional Budget Act to establish a federal regulatory budget and impose cost controls on the creation and enforcement of regulations.

## 8. H.R. 2779, ALERT Act of 2021

This bill would require a monthly update from executive agencies with detailed information about any new rules or regulations that they are working on. This legislation would also require the White House Office of Information and Regulatory Affairs (OIRA) to issue an annual report detailing the cumulative costs of all regulations from the previous 12 months.

#### 9. H.R. 2879, Nickel Plan Act

The bill would require the federal government to reduce its budget by one nickel for every dollar it spends annually over a period of five years in order to put us on a path to a fiscally responsible balanced budget.

## 10. H.R. 3045, No Regulation Through Litigation Act

This bill would limit the ability of federal agencies to enter into settlement agreements and consent decrees that effectively create new regulations without any authorization by elected representatives.

## 11. H. Res. 1077, Less Is More Resolution

The resolution would amend House rules to require lawmakers to either cut or condense at least two federal government programs of equal or greater budgetary impact before establishing a new program.

## **Securing Our Border**

I have been to the Southern Border four times since I took office. That is four times more than Joe Biden has been there despite a surge of 2.2 million border crossings during his first year in office. Sadly, criminal activity, drugs and human trafficking are too easily flowing across our border. I am fighting against the irresponsible policies of the Biden Administration that are turning every town in America into a border town.

## 12. H.R. 398, No Asylum for Criminals Act of 2021

This bill would codify and strengthen Trump Administration reforms to the asylum system by disqualifying criminals from eligibility.

## 13. H.R. 991, Preserving Safety Net Integrity Act of 2021

This bill would prohibit the Biden Administration from rescinding Trump's "public charge" rule, which requires potential immigrants to verify their financial independence before coming to the United States.

## 14. H.R.4199, No Taxpayer Funding for the Central American Minors

This bill would block taxpayer funding for a chain-migration program that was reinstated and expanded by the Biden-Harris Administration.

## 15. H.R.6628, Close Biden's Open Border Act

This bill would block taxpayer funding to the UN for two years, to pay for the cost of spending \$15 billion to finish Trump's border wall.

## 16. H.R.7024, Every Town A Border Town Act

This bill would declare MS-13 a foreign terrorist organization.

## **Fighting for Election Integrity**

In order for our civil society to move forward, everyone must have confidence in the outcome of our elections.

## 17. H.R. 6446, One Citizen One Vote Act

This legislation would prohibit federal funds for states or localities that have election practices that facilitate cheating – including unsolicited mail ballots, drop boxes outside of polling places, ballot harvesting, not requiring photo IDs, and permitting non-citizen voting.

## **Protecting Our Rights from COVID Mandates and Lockdowns**

The government's response to the pandemic has resulted in a loss of our freedoms, tremendous damage to our economy, and irreparable harm to our children.

## 18. H.R. 754, Protecting Religion from Government Act of 2021

This bill would protect all Americans' First Amendment rights by allowing citizens to sue state or local governments that seek to stop people from attending religious services. This legislation empowers houses of worship to sue their state or locality if they implement regulations or shutdowns infringing on their right to worship.

## 19. H.R. 755, Right to Earn a Living Act of 2021

This bill would prevent Congress from subsidizing haphazard and costly lockdown policies largely implemented by Democrat state and local officials. Specifically, any local or state government that prevents small businesses from opening, limits their hours of operation, occupancy, or ability to conduct business would not be eligible to receive a federal bailout from the Coronavirus Relief Fund.

## Standing for the Sacred Right to Life

Every American, born or unborn, has a God-give and Constitutionally protected right to life.

## 20. H.Res. 389, National Pregnancy Center Week

This resolution designates the week of November 8<sup>th</sup> as National Pregnancy Center Week.

## 21. H.R.5136, Teleabortion Prevention Act of 2021

This legislation would make it a federal offense for an abortionist to provide a chemical abortion without being physically present to examine the patient.

## **Guaranteeing the Second Amendment**

*The Second Amendment is the Constitutional right that secures all others.* 

## 22. H.R. 2469, SHUSH Act

This bill would deregulate suppressors at the federal level and preempts state law that regulates, taxes, or prohibits the possession of suppressors.

### 23. H.R.3823, PISTOL Act

This bill would prevent the Biden Administration from arduously regulating pistol braces by clarifying that what constitutes a "pistol" is not subject to bureaucratic interpretation.

## **Equipping Law Enforcement**

Democrats are trying to run away from their soft-on-crime calls to "defund the police" but I want to strengthen local law enforcement.

## 24. H.R. 2314, Protect Our Police Act

This bill would prohibit the Biden Administration from unilaterally issuing any restriction on the 1033 Program, which allows police departments access to life-saving military surplus equipment. This legislation will ensure that law enforcement has the necessary equipment to fulfill their job duties and keep communities safe.

## **Providing for our Veterans' Future**

We must honor our commitment to the men and women who fought for our country.

## 25. H.R.5901, Veterans Education is Timeless Act

This bill would remove the time limits on six Veterans and Survivors Education programs so that eligible veterans and their dependents can use these benefits regardless of age or timing.

## **Standing Up to China**

Along with Russia, the Communist Chinese Party is the greatest threat to America in the years to come.

## 26. H.R. 992, No Taxpayer Funding for the Chinese Communist Party (CCP) Act of 2021

This bill would require the Attorney General to provide a report to Congress within one year of enactment on the extent to which Communist China has benefited from taxpayer funded research. This report would include a list of United States Government-funded entities, such as research institutions, laboratories, and institutions of higher education, including an estimate in the number of nationals hired or involved in research projects.

## 27. H.R. 3465, Iran China Accountability Act

This bill would block any taxpayer dollars from being used to advance a nuclear agreement with Iran until Iran has terminated its cash ties with China and requires Iran to terminate its ties to terrorist groups like Hamas. In addition, the bill requires Iran to destroy all its nuclear and missile capabilities and infrastructure before any nuclear agreement is advanced.

## Strengthening our Economy and Workforce

The free market has lifted more people out of poverty around the world than any other system. Instead of celebrating our economic system, Democrats and their allies in the labor unions are an ongoing threat to our prosperity.

## 28. H.R. 2218, Davis-Bacon Repeal Act

This bill would repeal the Jim Crow era "Davis-Bacon" law which requires the federal government to pay the "prevailing wage," which dramatically inflates the cost of taxpayer funded construction and infrastructure.

### 29. H.R. 2403, Prohibit Neutrality Agreements

This bill would prohibit the ability of labor organizers to coerce employers into helping them organize unions among their employees.

#### 30. H.R. 7743, Small Businesses Before Bureaucrats Act

This bill would modernize the 1958 NLRB standards to ensure small businesses are exempt from NLRB authority.

## Reducing the Reach of Government in Healthcare

Government intrusion in the marketplace has done little more than raise health care costs and reduce health care options. And, the CDC failed the American people during the pandemic.

## 31. H.R. 4280, Health Agency Check-Up Act

This bill would create a commission to depoliticize and shrink the overall footprint of the CDC and other public health agencies.



## Working to Hold Your Government Accountable

Appropriate oversight, investigative questions, and seeking accountability and transparency are some of my responsibilities as your elected Representative. As part of this responsibility, I regularly lead and sign on to letters to the President, government agencies, Congressional leaders, and the Governor on your behalf.

One of the first letters I signed on to was with 200 Republicans, led by Rep. Jim Banks of Indiana, to save the Hyde Amendment and stop any taxpayer funding of abortions. <u>LINK</u>

I joined West Virginia Rep. Carol Miller along with 140 other Republicans to call out President Biden's anti-American energy policies. <u>LINK</u>

I joined Rep. Roy of Texas on a Bi-Cameral letter with 48 House and Senate Republicans calling on Congressional leaders to stop any funding for the unconstitutional vaccine mandate. LINK

I signed a letter with Rep. Babin (R-TX) and Rep. Banks (R-IN) and over 130 other Republicans to Sec. Mayorkas of Homeland Security regarding his dismantling of our border security and willful disregard for the enforcement of our immigration laws. <u>LINK</u>
