1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “Clarifying E–Rate Act
3 of 2024”.

4 **SEC. 2. TELECOMMUNICATIONS SERVICES FOR CERTAIN**
5 **PROVIDERS.**

6 (a) **SCHOOL BUSES AND OTHER LOCATIONS WHERE**
7 **LEARNING OCCURS.**—Section 254 of the Communications
8 Act of 1934 (47 U.S.C. 254) is amended—

9 (1) in subsection (b)(6), by striking “and class-
10 rooms” and inserting “(including classrooms associ-
11 ated with such schools, buses associated with such
12 schools (if owned, leased, or contracted by a school
13 and used primarily to transport students to and
14 from such school or activities related to such school),
15 and other locations where learning occurs as deter-
16 mined appropriate by the Commission)”;

17 (2) in subsection (h)(1)(B), by inserting “(in-
18 cluding, with respect to schools, to classrooms asso-
19 ciated with such schools, buses associated with such
20 schools (if owned, leased, or contracted by a school
21 and used primarily to transport students to and
22 from such school or activities related to such school),
23 and other locations where learning occurs as deter-
24 mined appropriate by the Commission)” after “edu-
25 cational purposes”; and

1 (3) in subsection (h)(2)(A), by striking “school
2 classrooms” and inserting “schools (including class-
3 rooms associated with such schools, buses associated
4 with such schools (if owned, leased, or contracted by
5 a school and used primarily to transport students to
6 and from such school or activities related to such
7 school), and other locations where learning occurs as
8 determined appropriate by the Commission)”.

9 (b) APPLICABILITY.—The amendments made by sub-
10 section (a) shall apply to amounts made available for fund-
11 ing year 2025 and each funding year thereafter.

12 (c) RULE OF CONSTRUCTION.—The amendments
13 made by subsection (a) may not be construed to affect
14 the authority of the Federal Communications Commission
15 with respect to the Declaratory Ruling in the matter of
16 Modernizing the E-Rate Program for Schools and Librar-
17 ies adopted by the Commission on October 19, 2023 (FCC
18 23–84; WC Docket No. 13–184).

19 (d) DETERMINATIONS.—Not later than 1 year after
20 the date of the enactment of this Act, the Federal Commu-
21 nications Commission shall promulgate a notice of pro-
22 posed rulemaking to—

23 (1) specify, if any, additional locations where
24 learning occurs that the Commission determines ap-
25 propriate for purposes of subsections (b)(6),

1 (h)(1)(B), and (h)(2)(A) of section 254 of the Com-
2 munications Act of 1934 (47 U.S.C. 254), as
3 amended by this Act; and

4 (2) establish an annual assessment process for
5 determining if further modifications are necessary
6 with respect to such additional locations.
